**Sub: Preparation of panel for appointment of Intelligence Officers on deputation basis in the Directorate of Revenue Intelligence (DRI), Zonal Unit Bangalore and Regional Unit, Mangalore – reg.**

The Directorate of Revenue Intelligence Unit, Zonal Unit, Bangalore is in the process of drawing a panel of willing and suitable candidates for filling up the post of Intelligence Officer (IO) on deputation basis at its Zonal Unit in Bangalore and Regional Unit in Mangalore. The details of vacancies are as under:

| Post                      | Vacancy                            | Station   |

| Intelligence Officer (IO) | 4 [2 (existing) + 2 (anticipated)] | Bangalore |
|                           | 1 (existing)                       | Mangalore |

The above vacancies will be filled by appointing suitable officers from the grade of Inspectors of Customs & Central GST and/or equivalent grade.

2. The selected officers, while working in the DRI on deputation basis, will be entitled for Deputation Allowance, as admissible. Normally, the Deputation is for a period of five years, which is extendable by another two years, one year at a time, subject to the willingness of the officers, his/her performance, concurrence of his/her Cadre Controlling Authority and approval of the competent authority. The candidates whose applications for the post have been forwarded by the concerned Organization and are duly received in this office will not be allowed to withdraw their candidature subsequently. The selected officers will have to make their own arrangements for residential accommodation.

3. Further, as per Para IV of Ministry's F.No.A-35017/28/92.AD.IIIB dated 30.06.1994 officers posted in certain charges/ organisation/assignments are required to complete the "Cooling Off" period of not less than two years before posting in DRI. However, the concerned Chief Commissioner of Customs/Central GST/Preventive has been given the power to relax the "Cooling Off" period.

4. It would be advantageous if the officers willing to apply for deputation/loan have relevant experience of working in Customs or/and have handled investigation, Data Analytics and possess good knowledge of Customs, NDPS laws and procedures.

5. The applications of eligible officers along with following documents should reach to the Additional Director, DRI, Bangalore Zonal Unit, No. 8(P)2, 1<sup>st</sup> Stage, 3<sup>rd</sup> Block, H.B.R. Layout, Kalyan Nagar Post, Bangalore – 560043 through proper channel:

- (a) Complete bio-data of the officer
- (b) Willingness of the officer
- (c) History of postings
- (d) ACR/APAR grading for the last five (5) years duly verified and attested by the Additional/Joint Commissioner (P & V)
- (e) Vigilance Clearance
- (f) No Objection Certificate of the Cadre Controlling Authority to relieve the officers, in the event of their selection
